SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures

Inhalation: Move into fresh air and keep at rest. In case of persistent throat irritation or coughing: Seek medical attention and bring these instructions.

Skin contact: Remove contaminated clothing immediately and rinse skin with rinsing cream. After this, apply a fatty cream. In case of rashes, wounds or other skin disorders: Seek medical attention and bring along these instructions.

Eye contact: Immediately flush with plenty of water for up to 15 minutes. Remove any contact lenses and open eyelids widely. If irritation persists: Seek medical attention and bring along these instructions.

Ingestion: Do not induce vomiting. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs. Rinse mouth with water. Get medical attention.

Symptoms/effects: Droplets of the product aspirated into the lungs through ingestion or vomiting may cause a serious chemical pneumonia. Be aware that symptoms of lung oedema (shortness of breath) may develop up to 24 hours after exposure.

Medical attention/treatments: In case of ingestion: Get medical attention.

SECTION 5: FIREFIGHTING MEASURES

5.1. Extinguishing media

Extinguishing media: Small fires: Extinguish with carbon dioxide or dry powder.

Do not use oil-contaminated clothing or shoes, and do not put rags moistened with oil into pockets.

Technical measures: Use work methods which minimise oil mist production.

Technical precautions: Mechanical ventilation may be required.

Technical measures for safe storage: Follow rules for flammable liquids. Large amounts and storages should be stored in accordance with national regulation on storage of flammable liquids.
