The site primarily constitutes vertical Lower Coralline Limestone sea-cliffs, with boulder slopes close to the sea.

4.2 Quality and importance

The cliffs and extensive rocky area offer an ideal habitat for two species of sea-bird populations, namely a population of ca. 500-1000 pairs of Cory`s Shearwater *Calonectris diomedea* (Annex I, Birds Directive) and a population of ca. 100-200 pairs of Yelkouan Shearwater *Puffinus yelkouan* (Annex I, Birds Directive).
