THE Environment and Resources Authority is issuing this Emergency Conservation Order in accordance with Article 69 of the Environment Protection Act 2016, Chapter 549 of the Laws of Malta, on:

It-Tieqa, Dwejra (Qawra – Għawdex)

It-Tieqa, Dwejra (Qawra Area – Għawdex)

kif muri fil-pjanta annessa fi Skeda I f'pagna 9728, minhabba li dan is-sit huwa ta' importanza ambjentali u fil-bżonn ta' konservazzjoni.

as per attached site plan under Schedule I on page 9729, due to its environmental importance and need of conservation.

L-Awtorità qiegħda b'hekk toħroġ Ordni ta' Emerġenza għall-Konservazzjoni għar-rigward ta' dan is-sit imsemmi hawn fuq, skont Artikolu 69 tal-Att dwar il-Protezzjoni tal-Ambjent għal skopijiet ta' konservazzjoni. Il-kundizzjonijiet li ġejjin japplikaw:

The Authority is hereby issuing an Emergency Conservation Order in respect of the above site as described thereto in accordance with Article 69 of the Environment Protection Act, 2016 for the purposes of conservation. The following regulations shall apply:

No person shall, unless authorised by the Authority:

(i) jaċċessa, jimxi, jagħmel *abseiling*, jixxabbat, jew jaqbeż miż-zona n-naħa tal-baħar indikata b'linja bejn il-kordinati A (E426918, N3990207) u B (E426931, N3990176) u b'bordura kontigwa kif indikat fil-Mappa 1 tal-pjanta;

(i) access, walk, abseil, climb, or jump off the seaward area demarcated by a line between the coordinates A (E426918, N3990207) and B (E426931, N3990176) and a contiguous border, as indicated in MAP 1 of the site plan;

(ii) jaċċessa ż-zona fil-baħar immedjatament taht it-Tieqa kif indikat fil-Mappa 2 tal-pjanta;

(ii) access the marine area immediately beneath it-Tieqa as indicated in MAP 2 of the site plan.

Din l-Ordni ta' Emerġenza għall-Konservazzjoni għandha tibqa' valida sat-2 ta' Gunju, 2017 u għandha tkun mingħajr preġudizzju għar-Regolamenti tal-2006 dwar il-Protezzjoni tal-Flora, Fawna u Ambjenti Naturali (L.S. 549.44).


This Emergency Conservation Order shall be valid from the date of issue up to the 2nd June, 2017 and shall be without prejudice to the Flora, Fauna and Natural Habitats Protection Regulations, 2006 (SL 549.44).


Any offence against this Conservation Order shall be punishable in accordance with Article 84 (1) (b) of the Environment Protection Act.

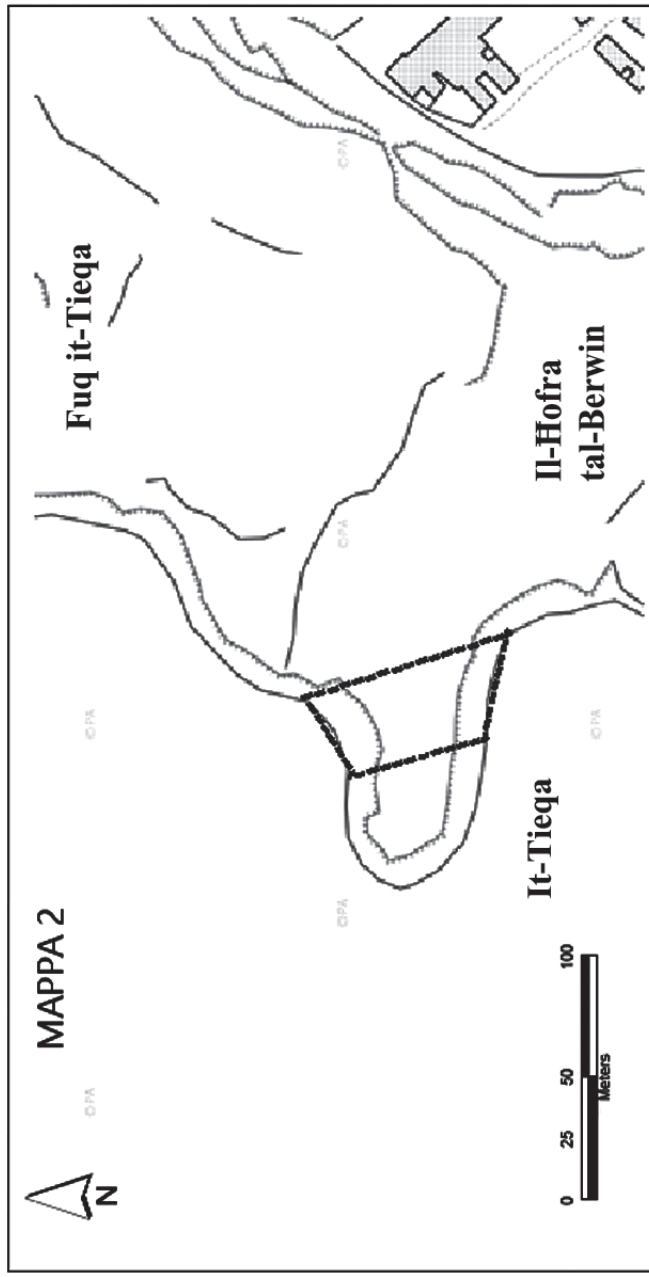
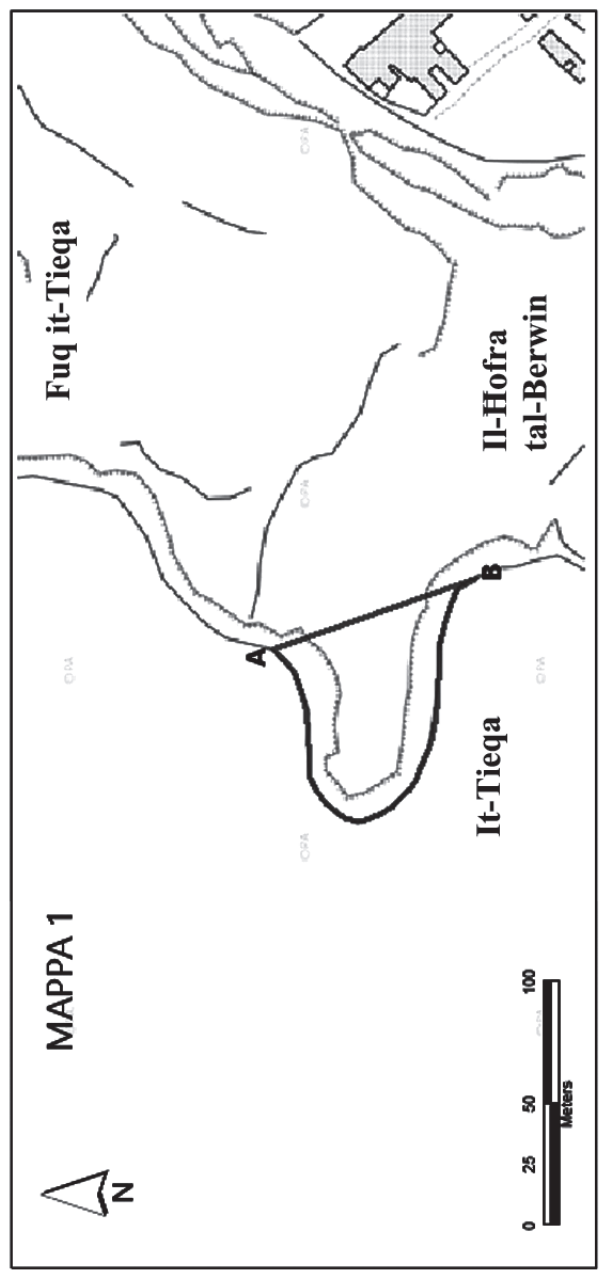


