In conformity with Regulation 3(8) of the Environmental Impact Assessment Regulations, 2007 (S.L. 549.46) with respect to the application mentioned hereunder, the Environment and Resources Authority has determined that

Dan huwa mingħajr preġudizzju għall-obbligi ambjentali li huma speċifikati fil-kundizzjonijiet tal-proġett propost.

Id-Deskrizzjoni tal-Proġett (PDS) li giet ipprezentata bħala parti mill-applikazzjoni kkunsidrat b'mod suffiċjenti l-kwistjonijiet li jolqtu l-ambjent u għaldaqstant it-teħjiġja ta' Dikjarazzjoni dwar l-Ippjanar Ambjentali mhux se żżid informazzjoni ġdida peress li l-Awtorità għall-Ambjent u r-Riżorsi għandha l-informazzjoni kollha meħtieġa sabiex tiddetermina l-applikazzjoni kif gie konkluz fl-*screening* tal-proġett skont l-Iskeda IB tal-istess Regolamenti.

 Post: Sit f'Triq Maddorbu, il-Qrendi, Malta
 Proposta: Konverżjoni ta' barriera li m'għadiex tintuża għal '*heritage park*' u '*transport museum*'. L-applikazzjoni tinkludi sanzjonijiet ta' interventi strutturali li diġà saru bħalma hu muri fit-tpingġijiet u xogħlijiet proposti. L-interventi proposti jinkludu l-inkorporazzjoni tal-użu ta' klassi 4C, zona għall-wirjiet, zona għar-restawr tal-karozzi, l-introduzzjoni ta' pont tal-injam u parkeġġ. Interventi għal sanzjoni jinkludu xogħlijiet ta' skavar, hitan strutturali, pont tal-injam, tisbiħ ta' rampa u l-estensjoni minuri għall-istrutturi eżistenti.

Dawn l-effetti potenzjali fuq l-ambjent, flimkien ma' numru ta' miżuri biex jittaffa l-impatt, ġew identifikati fid-Deskrizzjoni tal-Proġett (PDS). Il-PDS flimkien mal-ġustifikazzjoni għall-eżenzjoni mill-Istudju dwar l-Impatt Ambjentali ġew sottomessi lill-Awtorità għall-Ambjent u r-Riżorsi fis-26 ta' Jannar 2016 u t-3 ta' Frar, 2017 rispettivament.

Iż-zona għall-iżvilupp propost kienet fil-passat użata bħala barriera (ġebel tal-franka) u, ladarba eżawrita, is-sit thalla mitluq għal ħafna snin. Sadanitant is-sit tnaddaf minn fdalijiet, metall skreppjat u veġetazzjoni. Permezz ta' din il-proposta, li tinkludi wkoll *landscaping*, is-sit se jiġi restawrat.

the proposal is unlikely to result in environmental impacts that can be effectively addressed in an Environmental Impact Assessment. Therefore, the Director agrees that the proposal does not require the preparation of an Environmental Planning Statement (EPS). This is without prejudice to the environmental obligations being specified in the proposed project conditions.

The Project Description Statement (PDS) presented as part of the application has considered the environmental issues in a sufficient manner such that the preparation of an EPS would not add any new information and the Environment and Resources Authority has all the necessary information to determine the application as concluded in the project screening according to Schedule IB of the same Regulations.

A detailed justification is presented below:

Reference Number: PA03858/16
 Location: Site at Triq Maddorbu, Qrendi, Malta
 Proposal: Conversion of a disused quarry to heritage park and transport museum. Application includes sanctioning of structural interventions already carried out as shown in drawings and proposed works. Proposed interventions include the incorporation of class 4C use, area for display of exhibits, area for car restoration, introduction of timber bridge and parking area. Interventions to sanction include excavation works, structural walls, timber bridge, embellishment of ramp and minor extension to existing structures.

The following potential environmental impacts were identified and mitigation measures proposed in the Project Description Statement (PDS) submitted to ERA on the 26th January, 2016, and the justification for exemption from carrying out an Environmental Impact Assessment (EIA) submitted on the 3rd February, 2017.

<i>Land use</i>	<i>The area for the proposed development has in the past been utilised for quarrying activities (soft stone) and once exhausted, the site was left derelict for many years. This area was since cleared from debris, scrap metal and vegetation. Through the proposed after use, including landscaping the site will be restored.</i>
Impatt viziv	Il-proposta mhux se tkun vizibbli mill-livell tat-triq, billi l-mużew propost se jkun taht il-livell tat-triq. Il-landscaping estensiv tas-sit se jtaffi kwalunkwe impatt vizwali perċepit.
<i>Visual amenity</i>	<i>Proposal will not be visible from road level as the proposed museum will be below road level. The extensive landscaping of the site will also mitigate any perceived visual impacts.</i>
Traffiku	Investigazzjonijiet tal-istat tat-traffiku eżistenti nnutaw problemi minuri li jikkonċernaw il-wisa' tat-toroq minhabba li Triq Maddorbu hija mserrpa. Madankollu, l-impatti mhumieq meqjusa sinifikanti minhabba li l-ammont ta' traffiku tul din ir-rota huwa baxx. Kemm waqt il-kostruzzjoni kif ukoll waqt l-operat se jiġi pprovdut parkeġġ għall-vetturi kbar u żgħar.
<i>Traffic</i>	<i>Investigations of existing traffic conditions have noted minor problems concerning road widths owing to the winding nature of Triq Maddorbu. However, impacts are not considered to be significant in view of the low volume of traffic along this route. During both construction and operation, adequate parking provision will be provided for large and smaller vehicles.</i>
Impatt fuq il-wirt kulturali	Il-proposta qed tfitteq li tintegra d-dolmen (Misraħ Sinjura Dolmen, magħrufa wkoll bħala l-Ħaġar l-Imsaqqa) fis-sit. F'dan il-każ, qed jiġu proposti konsultazzjoni u monitoraġġ arkeoloġiku b'kordinazzjoni mal-Sovrintendenza tal-Wirt Kulturali
<i>Impact on cultural heritage</i>	<i>The proposal is seeking to integrate the dolmen (Misraħ Sinjura Dolmen, also known as il-Ħaġar l-Imsaqqa) on site. In this instance, consultation with the Superintendence of Cultural Heritage (SCH) is required especially regarding monitoring of on-site works.</i>
Storbju u vibrazzjonijiet	Storbju u vibrazzjoni waqt il-kostruzzjoni huma mistennija li jkunu limitati għal attivitajiet tipikament assoċjati f'siti ta' kostruzzjoni. Matul l-operat, l-istorbju u vibrazzjonijiet mhumieq mistennija li jkunu sostanzjali. Minhabba li s-sit jinstab taht il-livell tat-triq, mhux mistenni li jkun hemm impatt sinifikanti ta' storbju. Dan billi kull hoss se jiġi skrinjat/rifless mill-ħitan tal-barriera nnifisha. Barra minn hekk, kwalunkwe impatt jista' jittaffa b'mod suffiċjenti permezz ta' miżuri li jistgħu jiġu amministrati permezz ta' reġistrazzjoni ambjentali.
<i>Noise and vibrations</i>	<i>Noise and vibration during construction are expected to be limited to those typically associated with normal construction site activities. During operation, noise and vibrations are not expected to be substantial. The proposal is not expected to have a significant impact on noise given that being located below road level, any noise will be screened/reflected by the quarry walls themselves. Furthermore, any impacts can be mitigated sufficiently through measures which could be managed by means of an environmental registration.</i>
Hoġkien ta' skart	L-ebda skart mhu mistenni li jiġi ġenerat waqt it-tindif tas-sit, u l-ebda twaqqiġ mhu se jseħh. Ammont żgħir ta' skart huwa mistenni li jiġi ġenerat matul il-kostruzzjoni u l-aħħar fażijiet ta' irfinitura. Matul l-operat, l-attivitajiet fuq il-post mhumieq mistennija li jiġġeneraw ammonti sinifikanti ta' skart. L-iskart mistenni matul il-fażi tal-operat jinkludi skart munici-pali, skart minn attivitajiet ta' tindif, żjut użati, sustanzi kimiċi, fluwidi u/jew acidi u skart ieħor. Kwalunkwe skart generat, kemm perikoluż u dak mhux perikoluż, għandu jiġi ġestit f'konformità mal-leġislazzjoni rispettiva.
<i>Waste generation</i>	<i>No waste is anticipated during site clearance, and no demolition works will take place. A small amount of waste is expected to be generated during construction and finishing phases. During operation, the activities on site are not expected to generate significant amounts of waste. Waste expected during the operational phase include municipal waste, cleaning activities, spent oils, chemicals, fluids and/or acids and other wastes. Any waste generated be it hazardous or non hazardous should be managed in line with the respective legislation.</i>

<p>Kwalità tal-ilma/Tixrid tnixxijiet fl-ambjent</p> <p><i>Water quality/Spillages/ leaks into the environment</i></p>	<p>In vista li l-pjan ta' ġestjoni tal-iskart taż-żona se jintuża sabiex jiġi assigurat li l-unitajiet kollha jkollhom sistema sigillata ta' drenagg biex ikun żgurat li l-ebda sustanzi kimiċi jew sustanzi perikolużi ma jkunu mitfughin qabel ma jiġu trattati, il-proposta mhix mistennija li jkollha impatt sinifikanti fuq il-kwalità tal-ilma minn tixrid u tnixxijiet fl-ambjent. Miżuri oħra ta' tnaqqis jinkludu <i>spill kits</i>, art impermeabbli u facilitajiet tal-ħasil tar-roti.</p> <p><i>The proposal is not expected to have a significant impact on water quality through spillages and leaks into the environment in view that an area-wide waste management plan will be employed to ensure that all units have a sealed drainage system to ensure that no chemicals or hazardous substances are discharged without prior treatment. Other proposed mitigation measures include spill kits, impermeable ground and wheel washing facilities.</i></p>
