**AWTORITÀ TA' MALTA DWAR L-AMBJENT  
U L-IPPJANAR**

**Notifika dwar l-Eżenzjoni minn Studju  
tal-Impatt Ambjentali**

BI qbil mar-Regolament 3(8) tar-Regolamenti tal-2007 dwar l-Istima tal-Impatt fuq l-Ambjent (Avviż Legali 114 tal-2007), u minħabba li l-Awtorità ta' Malta dwar l-Ambjent u l-Ippjanar jidhrilha li l-proposta mhux probabbli li jkollha impatti sinifikanti fuq l-ambjent, id-Direttur għall-Harsien tal-Ambjent jaqbel li l-proposta ma teħtieġx Studju dwar l-Impatt Ambjentali (EPS).

Id-Deskrizzjoni tal-Proġett (PDS) li ġiet ipprezentata bħala parti mill-applikazzjoni kkunsidrat b'mod suffiċjenti l-kwistjonijiet li jolqtu l-ambjent u għaldaqstant it-thejjija ta' studju dwar l-impatt ambjentali mhux se żżid informazzjoni ġdida peress li l-Awtorità għandha l-informazzjoni kollha meħtiega sabiex tiddeċiedi dwar din l-applikazzjoni. Skont l-informazzjoni li ġiet ipprezentata fid-Deskrizzjoni tal-Proġett (PDS) u fil-valutazzjoni li saret skont l-Iskeda IB tal-istess Regolamenti, ma jidherx li l-proposta se jkollha impatti sinifikanti fuq l-ambjent.

Proposta: Židiet u tibdiliet ta' lukanda eżistenti jikkonsistu f'daħla ġdida; estensjoni tar-restorant u l-kċina; bini ta' kmamar li jħarsu fuq il-bahar; bini tal-hames sular irtirat mill-faċċata tal-lukanda; żieda ta' sundeck fuq il-bejt bil-pool; rilokazzjoni tal-entratura tal-post tal-ħatt; manutenzjoni u estensjoni tal-promenade; landscaping ta' parkeġġ pubbliku u l-ġestjoni tat-traffiku mat-triq li ddur mal-lukanda.

*Proposal: Proposed additions and alterations to existing hotel consisting of new entrance/reception; extension to restaurant and kitchen; additions of sea view rooms; additions of recessed floor (level 5); addition of roof level sundeck with splash pool; re-location of loading bay and goods entrance; pedestrianization, extension and landscaping of public sea front promenade; proposed construction and landscaping of public parking area and new traffic arrangements for hotel ring road.*

**Notification of Exemption of Environmental  
Planning Statement**

IN conformity with Regulation 3(8) of the Environmental Impact Assessment Regulations (Legal Notice 114 of 2007), and in view of the fact that MEPA has determined that the proposal is unlikely to have significant environmental impacts, the Director of Environment Protection agrees that the proposal does not require the preparation of an Environmental Planning Statement (EPS).

The Project Description Statement (PDS) presented as part of the application has considered the environmental issues in a sufficient manner such that the preparation of an EPS would not add any new information and MEPA has all the necessary information to determine the application. From the information presented in the PDS and screening according to Schedule IB of the same Regulations, the proposal is not likely to have significant environmental effects.

The following potential environmental impacts were identified and mitigation measures proposed in the Project Description Statement (PDS) submitted to MEPA on the 7th October, 2013 and the justification for proposal from carrying out an Environmental Impact Assessment (EIA) submitted on 4th February, 2014.

Impatt viživ	Il-fotomontaġġi juru li l-proposta tidher mil-madwar kollu, u għaldaqstant jistgħu jarawha diversi persuni. Minħabba li d-disinn tal-lukanda huwa bħal dak eżistenti, il-bidla fil-kwalità tal-veduta hija limitata.
<i>Visual Amenity</i>	<i>Photomontages submitted indicate that the proposal is visible from all the surrounding areas, and may be viewed by sensitive receptors. However, given that the extension has an identical design to the one of the existing hotel, the change in visual amenity is low.</i>
Impatt fuq l-użu tal-art u tal-kosta	Id-daqs u n-natura tal-progett propost mhux se jirriżulta f'impatt sinifikanti fuq l-użu tal-art u tal-kosta. Madankollu huwa neċċesarju li l-iżvilupp ma jieħux iż-żejjed mill-art tal-madwar u tal-kosta barra iż-żona ta' żvilupp. Dan għandu jiġi indirizzat permezz tal-proċess għall-permess tal-iżvilupp.
<i>Land use and coastal impact</i>	<i>The size and nature of the proposed project will not result in significant land use and coastal impacts. Nonetheless, it is imperative that the project does not entail the further uptake of land and coast outside the development zone. This should be addressed through the mainstream development planning process.</i>
Wirt kulturali	Fdalijiet ta' wirt kulturali li jinsabu fi 200 metru mill-konfini tas-sit jinkludu It-Torri tas-Sgħajtar (Il-Batterija ta' Wied Musa), <i>Defence post</i> ta' żmien it-Tieni Gwerra Dinjja; Wied Musa żona ta' lqugħ militari, It-Torri tal-Bir, u ir-Ramla tal-Bir żona ta' lqugħ militari. Il-probabbiltà li jiġu affetwati fdalijiet ta' wirt kulturali fuq is-sit hija remota. Minkejja dan, huwa propost li x-xogħliji waqt il-kostruzzjoni jkunu mgħassha minn arkeologu kkwalifikat.
<i>Cultural Heritage</i>	<i>Cultural heritage features within 200 metres radius of the site include It-Torri tas-Sgħajtar (Il-Batterija ta' Wied Musa); World War II beach post ruins; Wied Musa military buffer zone; It-Torri tal-Bir; and Ir-Ramla tal-Bir military buffer zone. The probability of the works impacting cultural heritage features on site is remote. Nonetheless, monitoring by a qualified archaeologist is recommended to be carried out during the construction phase.</i>
Hsejjes u trabijiet waqt il-faži ta' kostruzzjoni	Hsejjes u trabijiet waqt it-tindif u t-thaffir tas-sit u l-bini tal-estensjoni kapaċi jaffetwaw lir-residenzi tal-madwar u nies oħra li jiffrekwentaw is-sit. Madanakollu, se jkun hemm mizuri biex jittaffew it-trabijiet u l-hsejjes skond kif imsemmi fir-Regolamenti tal-2007 dwar l-Immaniġġar Ambjentali tas-Siti tal-Kostruzzjoni (Avviż Legali 295 of 2007).
<i>Construction Phase Noise and Dust Emissions</i>	<i>Dust and noise emissions during site clearance, excavation and construction may affect the nearby residents and people frequenting the site. Dust and noise abatement measures in accordance with the Environmental Management Construction Site Management Regulations, 2007 (Legal Notice 295 of 2007) shall further minimise the impact.</i>
