The Environment and Resources Authority (ERA) hereby grants consent in accordance with the application described above, of the operations detailed in the attached IPPC permit consisting of the following documents and associated approved documents:

This permit regulates the management and operational conduct of the site.

This permit is granted until 25 August 2021; however, it may be varied/surrendered/transferred as specified in the introductory note of the regulatory framework permit and in each of the subsidiary permits. An application for renewal of this permit, including the sub-permits, is to be submitted **at least six (6) months** prior to expiry of this permit.

This permit is granted subject to the following conditions:

1. Operations are to conform to the standards and operating conditions specified in the IPPC permit documents (IP 0002/07/G, IP 0002/07/Gi, IP 0002/07/Gii, and IP 0002/07/Giii) and the associated approved documents as listed above.
2. Enemalta plc., in its role as Permit Coordinator in the regulatory framework permit IP 0002/07/G, shall:
 - a. Provide a financial guarantee of €1,000,000 to secure the obligations listed in the respective permit. This guarantee will have to be maintained throughout the lifetime of the permit. Following variations to this permit, the Authority may require amendments to the bank guarantee without any prejudice.
 - b. Provide a financial guarantee of €150,000 to the Environment and Resources Authority as required by permit IP 0002/07/G, to cover the costs relating to studies on air quality monitoring and assessment. This guarantee will have to be maintained throughout the lifetime of the permit unless otherwise instructed by the Authority
3. The Operator in IP 0002/07/Gi, ElectroGas Malta Ltd, shall:

- a. Provide a financial guarantee of €3,000,000 to secure the obligations listed in the respective permit. This guarantee will have to be maintained throughout the lifetime of the permit. Following variations to this permit, the Authority may require amendments to the bank guarantee. In view of the completion of the commissioning phase to its satisfaction the Environment and Resources Authority hereby authorises the release of €2,500,000 from bank guarantee number G64TFC46499 (amounting to €5,000,000) thus retaining the amount of €3,000,000.
- b. Pay an annual contribution fee which consists of the fixed annual amount of €2,926 and a variable addition reflecting the cost for inspections at €200 for each inspection by the Environment and Resources Authority as per the provisions of Regulation 4(7) of the Industrial Emissions (IPPC) Regulations, 2010.

For the initial year, a total of twelve (12) inspections are expected to be carried out the cost of which is being divided between the three (3) Operators. The variable addition shall therefore be that of €800 for four (4) inspections. The latter variable component depends on the actual number of site inspections, which is determined by the performance of the operator.
