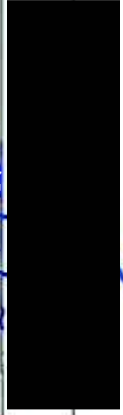

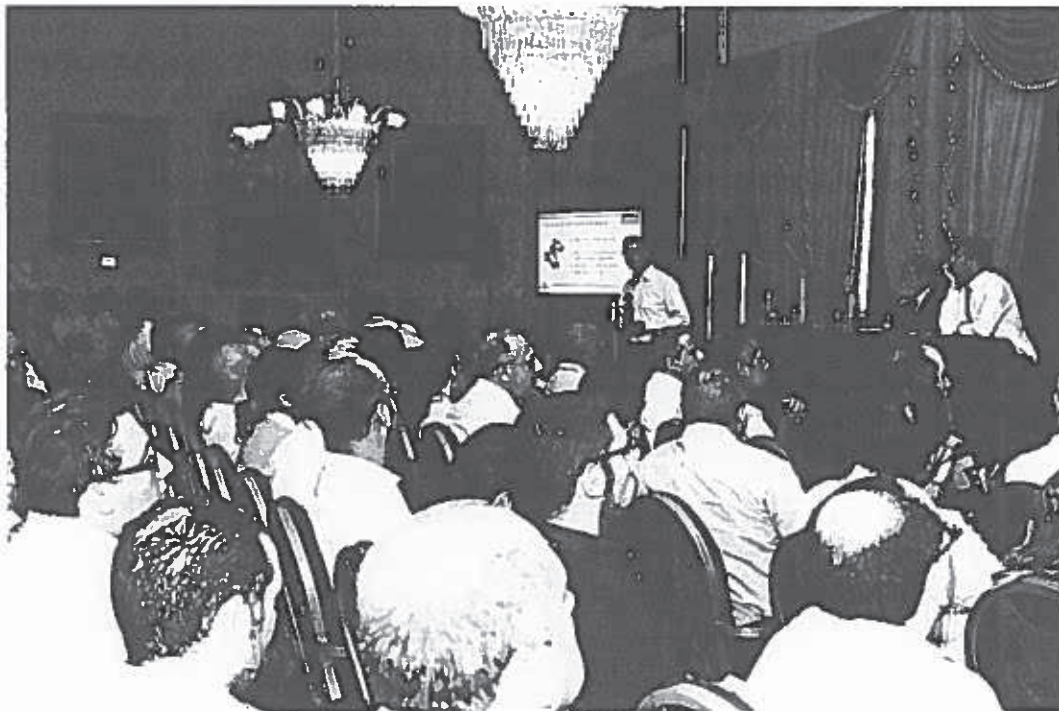

Section 11 - Information and Awareness Campaigns

Information Session regarding the WEEE implementation



GreenPak in collaboration with the Malta Chamber of Commerce, Enterprise and Industry on the 22nd July 2015 organized an information session with regards to changes in the Eco-contribution system and the WEEE Directive. The event was chaired by the Director General of the Chamber, Mr Kevin Borg.

ERA officials, Mr Darren Cordina and Mr Kevin Mercieca explained that the EEE schedules in the Eco Contribution Act will be removed as from the 1st September 2015. Companies which put EEE products on the Maltese market are expected to either join an authorised waste management scheme or show concrete plans of self-compliance by the end of August and notify the competent authority (ERA) accordingly.

Ing. Mario Schembri, CEO of Green Pak Coop Society Ltd, then gave a presentation in which he explained that GreenPak has, since 2005, assisted hundreds of organizations meet their legal liabilities with regards to the Waste Packaging Regulations. Drawing from this extensive experience, the Co-operative has now also established a WEEE Compliance Scheme to assist organisations meet their legal liabilities under the WEEE regulations.
