3. Description must be precise as possible and include a three-letter code in accordance with Annex V to Regulation (EC) No 865/2006.
4. The country of origin is the country where the specimens were taken from the wild, born and bred in captivity, or artificially propagated.
5. Use one of the following codes to indicate the source:
 - W** specimens taken from the wild
 - R** specimens originating from a ranching operation
 - D** Annex A animals bred in captivity for commercial purposes and Annex A plants artificially propagated for commercial purposes in accordance with Chapter III of Regulation (EC) no 865/2006, as well as parts and derivatives thereof
