The Collective Organisation shall notify ERA and shall review the bank guarantee value within four (4) months thereafter. The bank guarantee provided for the previous operational year shall continue to be applicable to ensure compliance with these permit conditions until the new/updated Bank Guarantee for the active operational year is submitted, and the previous guarantee is in turn released by the Authority.”
