In this regards, no Producers/Members are to be accepted with the Authorised Packaging Waste Recovery Organisation for the beverage packaging falling under S.L. 549.134. Any Producers/Members who fall within the aforementioned criteria are to no longer remain members with the Authorised Packaging Waste Recovery Organisation accordingly, unless they place other packaging or packaging material other than the beverage containers referred to in S.L.549.134, which still requires participation in an Authorised Packaging Waste Recovery Organisation.”
