IN exercise of the powers conferred by sub-regulation (2) of regulation 4B of the Abandonment, Dumping and Disposal of Waste in Streets and Public Places or Areas Regulations and by sub-regulation 12A(2) of the Waste Regulations, the Minister responsible for the Environment is by virtue of this Notice establishing the date of 15th October, 2023, as the date on which enforcement will begin on recyclable waste disposed in black bags, such as beverage containers made of plastic or metal, containers of other domestic products such as soap containers and similar products, metal cans, and other packaging.
