

The attendance and completion of these courses will be required for the renewal of any application.

Regulation 21 and 22 provide for the offences and administrative penalties.

Regulation 23 provides for the revocation or temporarily suspension of the mason's licence for failure to comply with these regulations. The licence may be re-issued if actions are rectified and conditions may be imposed. The Courts may also suspend the licence or order the Authority to revoke the licence, and any suspensions or revocations will be made public on the Authority's website with the persons having the right to appeal.

Regulation 24 provides that persons who currently are licenced masons in accordance with the Code of Police Laws and whose licence is set to expire in the year 2024 shall be authorised to keep their licence until 31 December 2024, by which time a renewal application shall be submitted.

5. Concluding Section

These regulations shall come into force on such date as the Minister responsible for the construction industry, may by notice in the Gazette establish, and different dates may be so established for different provisions or different purposes of these regulations.
